Revised Invitation for Bid (IFB)

The Government of the People's Republic of Bangladesh has received loans from the Asian Development Bank (herein after called "the ADB") towards the cost of the Gas Transmission and Development Project and it is intended that a part of the funds will be applied to eligible payments under the contract for which this Re-Bidding Document is issued.

The Gas Transmission Company Limited (herein after called "the Purchaser") now invites sealed Revised Bid from eligible Bidders from member countries of the ADB for the supply and delivery of Pipeline Ball Valves for the Construction of 762mm (30") OD 51.00 km high pressure (1135 Psig) natural gas transmission pipeline from Monohordi to Dhanua and Elenga to East Bank of Jamuna Bridge (Details and Specifications are provided in Revised Bidding Document).

Delivery and services under the contract shall be completed as per time mentioned in the following table counting from 30 (thirty) days after issuance of Commitment Letter by ADB.

International Competitive Bidding will be conducted in accordance with the ADB's Single-Stage: Two-Envelope Bidding procedure and is open to all Bidders from eligible source countries. Details procedures are provided in the Revised Bidding Document of the following table:
