### Invitation for Bid (IFB)

The People's Republic of Bangladesh has received a loan from the Asian Development Bank (herein after called "the ADB") towards the cost of the Gas Transmission and Development Project and it is intended that a part of the funds will be applied to eligible payments under the contract for which this Re-Bidding Document is issued.

The Gas Transmission Company Limited (herein after called "the Purchaser") now invites sealed Bids from eligible bidders from member countries of ADB for supply and delivery of Pipeline Miscellaneous Fittings for the Construction of 762mm (30") OD 82 km high pressure (1135 Psig) natural gas transmission pipeline from Hatikumrul to Bheramara (Details and Specifications are provided in Bidding Document).

International Competitive Bidding will be conducted in accordance with the ADB's Single-Stage: Two-Envelope Bidding procedure and is open to all Bidders from eligible source countries.
